Now is the time to start thinking about it. There could be a financial study because that is what they felt should be done last time. Regarding security – they had some issues at the Clyde Court recently. They will be addressing their security issues as well. He has spoken with Sheriff Overmyer. He will probably be back to see the Commissioners once they have a more solid
