Beavers and other wild life have been successfully trapped and removed. There are two ways to approach this, either a group project or a conservation of improvement funding. Board could disagree but highly unlikely. They should have someone from Riley Township to consider this request. Lisa said they have already spoken and attended a board meeting so that should not me a problem. Next board meeting is Sept.14 at 7:00 a.m.

Judge Smith and Mary Ann Reser, Juvenile/Probate Court Administrator, met with the Commissioners to discuss furniture in the Juvenile and Probate Court. Judge Smith reiterated what he said in his email and the attachment that he sent them. He is not happy about the charge for installation of things they got wrong but doesn't know what kind of a deal has been worked out with the company.
