Health Department	Bethany Brown - Health Commissioner. Bethany came in at the request of the Commissioners to bring them up to date on what is happening at the Health Department. Commissioner Miller had some concerns and wanted Bethany to clarify information that was discussed at the last Health Department Board meeting. The one concern was regarding the accreditation process they have been going through over the last three years. There is a group that reviews documents presented by the County Health Department which is over 2,000 pages. They then come out for an on site visit. They felt the Health Department was well prepared and the site visit seemed to go well. They did receive the report and had about eighty pages of comments and concerns that the Bethany felt were easy fixes. There is another board that reviews the report and makes a decision on whether or not they receive their accreditation or if they are put on an action plan. Sandusky County was put on an action plan, sixty percent of the Boards are put on an action plan. Some fixes are detailing minute notes, working with the hospitals closer to find physicians and other concerns they want corrected. They will need to submit additional documentation and they will have one year after the action plan is approved to show the improvements requested. Bethany's plan is to have the plan approved and documents in to the Board by late summer. As part of the action plan the Commissioners are going to start meeting with Bethany on a quarterly basis to review Health Department happenings as well as keeping one Commissioner on the Health Board.
