	Kelly Askins, Dog Warden, and the Administrator talked with Mark Mulligan, Asst. Prosecutor, in regards to possibly leasing space on the electronic sign owned by the Dog Kennel. Currently the Visitors Bureaus has been managing the sign and posting events. Kelly does not want the responsibility of maintain the sign and asked about leasing advertising space. Mark did not recommend that Kelly take on this type of leasing. The recommendation was to sell the sign if it was no longer of use to the Dog Kennel. Commissioners agreed the sign should be sold. They suggested that Kelly take the sign out to Facility Management and put it on Govdeals for sale.			

	Commissioner Reiter received an email from Luke Harms from Whirlpool Corporation, Manager of Govt. Relations. He wanted to touch base because there are a few national media outlets in Clyde working on stories about Whirlpool. If we receive any inquiries, he wanted to make sure we focus on the importance of Whirlpool to the community and its long history in Clyde. If any Whirlpool trade related questions arise, he asked to redirect them to the Whirlpool media line.		
	Ron Hiser, Facility Management Director, and the Administrator met with Angie with WSOS to discuss the CDBG grant money. Angie went through what the process will be to request a change in the CDBG project. She felt that the new project presented should be the courthouse ramp and to do door openers and the bathroom updates as a separate project instead of adding them on to the ramp project. The ramp will use the grant funds. Commissioner Reiter suggested we possibly use Revolving loan fund money for the door and bathroom project. The Administrator will look in to this.

This will allow them to lease to schools, Sandco and Wynn Reeth without causing any issues. They have clients that do business with all and it benefits all the organizations as well as the clients.
