Review of External Board / Meetings Attended by Commissioners	Commissioners Miller and Zimmerman attended a SWOT meeting at Promedica on Monday. They were given a report on how Promedica has positioned themselves in the community. Some of the comments made by Pam Jensen, President of Fremont Promedica Hospital, was the amount of hours and the PT services that were removed from Promedica. They provide the services, they do not hire out for those services. They hired approximately two thirds of the outside staff to work at the Promedica center. They had been contracting with a linen service and the Fremont contract was turned over to Reno Services and the work has been kept in the County. They discussed different conditions that are automatic transfers to other facilities as they do not have the ability to treat those conditions. ER doctors will assure individuals are transferred to the proper facility. The living wage at Promedica is above normal. Hospital costs are their highest expense and they are working on that. 	79% of their billing for services due to non-payment. They do have a wellness program in the hospital. She said wellness is 20% about life choices. Promedica is too big and they want to make sure people don't get lost when they are transferred. They need to make sure these individuals can't be helped in Fremont before sending them to another facility. The hospital also talked about the remodeling that is still coming along. The Cancer Center is going to be expanded too. We have the lowest birth rate in history and those being born now won't live as long as we are now. One other challenge is that the population is growing and they are having issues finding employees.

The training was building them up to get a tactical rescue team together for the County. The purpose of the training is to put law enforcement in front of and behind the EMS to assure the safety of the medical personnel. They now have to start looking at the tactical geared needed. There was a compliment to Sandusky County for law enforcement to come in and help with the training and working with them. Captain McGinnis was asked to go to Detroit, Michigan to present a training on heads up CPR and their success rate. Chief Jackson presented his quarterly reports for review.

They have one week left before election day. They are trying to get as much information out to the community as possible. The levy is a renewal so there will not be any additional funding coming to the Health Department. Many of the services provided by the health department that are not covered completely by the levy funding. Most of these are covered by fees received by the Health Department. The nursing division that provided immunizations is only partially funded by the State. They have had to purchase the rest. They were unable to provide some of the vaccines and they were fortunate to receive support from Promedica for these vaccines. This is one program that will have to be cut if they lose their funding. They have many programs going on right now on prevention. They did just received a federal grant to assist on the opioid epidemic and they will be working with the mental health board on with this grant. Governor DeWine seems to be more engaged in the Health Department issues and supporting their issues. There was discussion with the citizens attending on how to help and how to support the Health Department. The levy only supports 20% if the Health Department budget.
