

Sheriff	Chris Hilton – Sheriff. Sheriff came in for a regular meeting with the Commissioners. Sheriff talked about the new Taser purchase. He would like to use his training funds for the first payment and then budget for the next four year payments. Tasers usually have a life span of five years, so you turn around and update. He has had many fleet issues. The new trucks should be here in June and the Explores should be here in October or November. He has had some personnel issues that lan Cantu, HR Specialist, has been very helpful. Commissioner Zimmerman talked about comments made at a meeting about the no wake zone in Wightmans Grove. The Sheriff places them but ODNR tells them where they need to be placed. He is obligated to place these per a grant agreement with ODNR. There was discussion regarding Conservancies and their rights. Sheriff went to Pennsylvania for an IGNITE program launch. It was a brand new jail that was amazing. There set up is different, they have Wardens and the Sheriff supervises the Wardens. Sheriff shared some statistics on the outcome of inmates graduating from the IGNITE Program. Sheriff informed the Commissioners Chief Hastings is retiring and he will be splitting his responsibilities between Major Kotsopoulos and Major Hatfield. He has been thinking about what he is going to do with the spot with Chief Hastings. He talked about hiring an IT person so he has someone in his office every day. There was discussion on this.
