Beth explained that Sandusky EDC has a partnership with the Erie County Port Authority. They have many programs that can help other counties. Sandusky County is already a member of a Port Authority and Beth has already received approval from the Port Authority for Sandusky County to also join the Erie County Port Authority. Greater Sandusky Partnership runs the Erie County Port Authority. There is a Capital Lease Program that assists with the purchasing of materials on large projects. The new law now makes it mandatory to have the Commissioners pass a resolution agreeing to join an additional Port Authority. Matt than explained how their program works.
